GI Reset features L-glutamine, an amino acid that provides structural and metabolic support for intestinal cells.* Zinc L-carnosine provides support for the health of the intestinal lining. N-acetyl-D-glucosamine supports a normal inflammatory response in the GI tract.*

GI Reset also contains a botanical blend of deglycyrrhizinated licorice (DGL) extract, aloe vera, marshmallow, okra extract, and cat's claw that provides support for healthy intestinal function by coating and soothing the intestinal lining, and these ingredients promote the body's natural gastrointestinal repair process.* Prune powder and citrus pectin support bowel regularity.* Methylsulfonylmethane (MSM) supports the structure, integrity, and permeability of the GI cell walls and a healthy inflammatory response.*
