Tri-K™ is a synergistic blend of vitamins K1 and K2, along with geranylgeraniol (GG), that work together to promote optimal delivery of vitamin K2 (as MK-4) to tissues supporting normal blood clotting, bone mineralization, and arterial elasticity.* Two softgels deliver 4,000 mcg of vitamin K1 (as phytonadione), 1,000 mcg of vitamin K2 (as menaquinone-4 [MK-4]), and 35 mg GG-Gold® (a patented form of GG) to support vitamin K status in the body.*

Both forms of vitamin K are important to our health. Vitamin K1 is the naturally occurring form found predominantly in leafy green vegetables, whereas vitamin K2 (as MK-4) is found in pastured eggs, grass-fed butter, meat, and some cheeses.

Vitamin K1 is essential for normal blood clotting.* Much of vitamin K1 is converted to vitamin K2 in the body. Vitamin K2 (as MK-4) activates a protein that binds newly absorbed calcium and helps to integrate it into the bones and teeth.* At the same time, vitamin K2 (as MK-4) may help discourage calcium deposition in the arteries.*

Due to the crucial role of this fat-soluble vitamin for blood clotting, bone health, and cardiovascular health, Tri-K™ may provide nutritional support for individuals who are at risk of bone loss, bone fracture, arterial stiffness, and other relevant conditions in which high doses of vitamin K1 and/or vitamin K2 may have beneficial effects.*
